1. NAME OF THE ASSOCIATION : TIRUMALA BALAJI EDUCATIONAL SOCIETY
2. LOCATION: BUKKARAYASAMUDRAM D.NO: # 25-97, BUKKARAYASAMUDRAM (V) EL ANANTAPURAM (DIST) - 515
3. MEMBERSHIP: The person who wants to enroll as member in society he has to be paid Rs. ^{100/-} towards monthly and also to be paid Rs. 500 /- towards monthly subscription. The person who fails to renew his membership before the end of three succeeding months automatically ceases to be a member. No member shall be entitled to vote whose subscription shall have been in arrear for a period not exceeding three months.
4. GENERAL BODY AND ITS FUNCTIONS:
 - i) To elect executive body or managing committee.
 - ii) To pass budget for ensuing and approve the expenditure statement for the previous year.
 - iii) To approve the report of the activities of the society.
 - iv) To appoint an Auditor.
5. EXECUTIVE BODY: The executive body shall consists of (9) NINE members of which the president, secretary and treasurer elected by the General Body to have over all supervision over the day today administration.
6. MEETINGS:
 - i) The general body shall meet once in a year in the month of AUGUST and the elections for the general body shall be conducted every three years to elect office bearers.
 - ii) Extra-ordinary meetings of the general body may be convened at any time when called for by the executive body within 10 days notice to all members.
 - iii) The executive body will meet once in a month or earlier if there is need for it.
7. DUTIES OF OFFICE BEARERS:
 - i) **PRESIDENT:** The president shall preside over all the meeting of the general body, governing body and sub-committee. He shall have the right to call for emergency meeting for transaction of the urgent matters if any. He can sanction expenditure to the extent of Rs: 10,000-00 /- at a time in an year subject to subsequent sanction in Governing Body.
 - ii) **VICE-PRESIDENT:** In the absence of the President he shall perform the functions of the president.

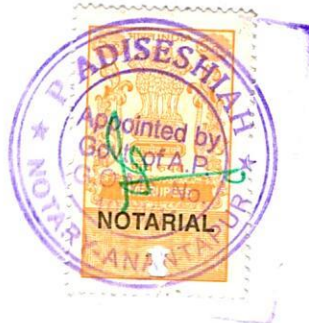


